2 Data subject rights for users of social media platforms

2.1 Right to information

You may request information on whether and to what extent your data is processed.

2.2 Right to rectification

If your data is incomplete or incorrect, you can request correction and/or completion at any time.

2.3 Right to erasure

You may request the erasure of your data, insofar as it is processed unlawfully, or the processing disproportionately affects your legitimate protection interests. Please note that there may be valid reasons that prevent immediate erasure, e.g. in the case of legally regulated storage obligations. Regardless of the exercise of your right to erasure, your data will be erased immediately and completely, when there is no contractual or legal obligation to store such data.

2.4 Right to restriction of processing

You may request the restriction of processing of your data, if:

- you contest the accuracy of the data, for a period that allows us to verify the accuracy of the data,
- the processing of the data is unlawful, but you oppose the erasure of the data and request restriction of use instead,
- we no longer need the data for the intended purpose, but you still require the data for the establishment, exercise or defence of legal claims, or
- you have objected to the processing of the data.



2.5 Right to data portability

You may request that your data which you have provided us is made available in a structured, commonly used and machine-readable format, and that you can transmit this data to another controller without hindrance, insofar as we process this data on the basis of your revocable consent or for the performance of a contract between us, and such processing is carried out by automated means.

If technically feasible, you can request direct transmission of your data to another controller.

2.6 Right to object

If your data is processed based on legitimate interest, you can object to this data processing at any time; this also applies to profiling based on these provisions. Then, your data will no longer be processed, unless compelling legitimate grounds for the processing are demonstrated, which override your interests, rights and freedoms as the data subject, or the processing serves the establishment, exercise or defence of legal claims. You can object to the processing of your data for the purpose of direct marketing at any time, without giving reasons.

2.7 Right to lodge a complaint

If you believe that the processing of your data violates German or European data protection law, we ask you to contact us to clarify any questions. Of course, you also have the right to lodge a complaint with the supervisory authority responsible for you, the relevant state authority for data protection supervision.
